## Cumberland Township Board of Supervisors November 7, 2013 Workshop Minutes

## Manager:

Mr. Thomas presented the 2014 Preliminary General Fund Budget. The budget is balanced and shows a surplus of \$51,139.00 in revenues (\$2,840,395.00) over expenditures (2,789,256.00). Mr. Thomas showed a Power Point presentation both summarizing the revenues and expenditures and the line item detail.

Police Chief Boehs and Lieutenant Guise also presented a Power Point presentation and explained the line item detail for the Police Department budget totaling a proposed \$1,140,275.00.

Mr. Thomas also presented the 2014 Preliminary Budgets for the Fire Tax Fund, Capital Reserve Fund, Park and Recreation Fund, Traffic Impact Fund and State (Highway Aid) Fund.

Mr. Thomas reported that the Board should review the budgets over the next two weeks and there can be discussion at the next workshop on November 21, 2013. He added that tentative approval of the budgets will be on the agenda of the November 26, 2013 regular meeting at 7:00 p.m. and final approval will be on the agenda of the December 17, 2013 regular meeting at 7:00 p.m.

November 26, 2013 – 6:30 p.m. hearing followed by regular meeting (Mr. Waybright will be absent)

Mr. Thomas presented a draft Memorandum of Understanding with the Gettysburg, Barlow and Greenmount Fire Departments and asked the Board to review this and it will be on their next workshop agenda.

Mr. Thomas reported that a Conditional Use application has been received from Harvest Investment Group for an Assisted Living Facility and the public hearing must be held on or before December 29, 2013. The Board scheduled the hearing for December 17, 2013 at 6:00 p.m. The regular meeting will follow the hearing.

Chair Underwood reported that the Keller Agricultural Security Area (ASA) will be discussed at the November 21, 2013 workshop.

Mr. Toddes reported that the Gettysburg Area Recreation Authority (GARA) has a tentative budget and they meet the first Tuesday of the month. He invited everyone to attend their meetings.
